1. Summary

1.1 In accordance with Section 15 of the Local Government and Housing Act 1989, it is the duty of the Council, at its Annual meeting, where it is divided into different political groups, to review the representation of different political groups on Committees and Sub-Committees.

2. Political Composition of the Council

2.1 Following the Council Elections on 5 May 2016, the political composition of the Council is:

3. Allocation of Committee Places

- 3.1 In accordance with Section 15 of the Local Government and Housing Act 1989 (LG&HA 1989) and Local Government (Committees and Political Groups) Regulations1990, where a Council is divided into different political groups, seats on Ordinary Committees have to be allocated to give effect to the following principles:
 - (a) all the seats on Committee are not to be allocated to the same political group;
 - (b) the majority of seats on a Committee should be allocated to the group which has the majority of the Authority's membership;
 - (c) subject to (a) and (b) above, the total number of seats on Committees must be allocated in proportion to the political strength on the Council; and
 - (d) subject to (a), (b) and (c) above the number of seats on each Committee must be allocated in proportion to the political strength on the Council.
- 3.2 A political group must comprise of two or more members and consequently the Conservative Independent Member, Councillor David Barton is not entitled to any Committee places on the Ordinary Committees.
- 3.3 The term "Ordinary Committees" have a special statutory meaning. They only include Committees that have delegated powers to discharge the Council's statutory functions.
- 3.4 The political proportionality rules do not apply to the appointment of the Cabinet under the Council's Constitution.

- 3.5 The Local Government (Public Health, Health and Wellbeing Boards and Health Scrutiny) Regulations 2013 made under the Health and Care Act 2012 provide that the Health and Wellbeing Board shall be a committee of the Council. The requirement for political balance does not apply to the Board and the Act requires that the Council membership is nominated by the Executive Leader (Leader of the Council.
- 3.6 A careful statistical analysis is considered prior to the allocation of the seats, to achieve the best fit both mathematically and to give effect to the principles cited above. In considering the statistical outcome of the elections and the allocation of seats, it is vital to appreciate that not all statistical outcomes can be rounded up and that there needs to be compromise in the system to achieve the overall apportionment of seats. In other words some statistics that would ordinarily be rounded up might need to be rounded down in order to give effect to the statistical apportionment of seats to each party.

The first step is to ensure that the allocation of seats reflects the outcome of the election. The second step is to ensure that the party with the most members is allocated the most seats. Following which the primary principle is that each party achieves their overall allocation of seats across all of the Ordinary Committees (Section 15 (5) (c) of the LG&HA 1989 refers). Where possible and subject to that primary principle, only then can the principles be applied to each and every committee. It is not possible to give effect to this last principle even though the statistics for each individual ordinary committee might suggest otherwise.

3.7 It is therefore recommended that the seats on the Ordinary Committees be allocated as shown below:

4. Appointment of Members to Committees

1. Introduction/Background

- 1.1 Correspondence has been received from the Joint Negotiating Committee for Chief Executives of Local Authorities (JNC) regarding the Local Authorities (Standing Orders) (England) (Amendment) Regulations 2015 (the Regulations) that replaced the statutory Designated Independent Person (DIP) provisions with an Independent Panel process. The Council is obliged by virtue of these new regulations to review its constitution, to accommodate changes to the procedure for disciplining and dismissing statutory officers. Statutory officers for these purposes are the Head of Paid Service (Chief Executive), the Section 151 Officer (Head of Corporate Resources) and the Monitoring Officer (Head of Regulation and Compliance).
- 1.2 The JNC has been working over recent months to update the Chief Executives' Handbook so that it reflects the new statutory process. The Regulations provide that where there is a proposal to dismiss a statutory officer the authority must appoint a Panel, and take into account any advice, views or recommendations of that Panel. The Panel should be a Committee of the Council, appointed under section 102(4) of the Local Government Act 1972 and should contain at least two independent persons appointed under s.28(7) of the Localism Act 2011.
- 1.3 There has been some uncertainty as to whether this requirement incorporated the need to maintain political balance in this Committee, i.e. that the requisite number of Councillors should also be appointed. The Department for Communities and Local Government has accepted that it is possible that the Panel can comprise only independent persons provided that is what the authority resolves and therefore in the JNC national model process the Independent Panel shall comprise only independent persons (at least two) appointed under S28(7) of the Localism Act 2011. In other words, no elected members should sit on the Panel.
- 1.4 Notwithstanding the view of the JNC, and in order to maintain flexibility in the Council's decision making processes, it is recommended that when considering

- such issues both the Employment Procedure Committee and the Appeals Committee can comprise both elected Members and Independent Persons.
- 1.5 The amendment recommended is that each case be considered on its merits and Councillors can resolve to participate in the committee or can resolve that the matter be dealt with exclusively by Independent Members. This approach can occur either at the Employment Procedure Committee stage and/or the Appeals Committee stage,.
- 1.6 Accordingly, it is recommended that the Terms of Reference of both the Employment Procedure Committee and the Appeals Committee contained in the Constitution be amended by the addition of the following:-

"That for the purposes of dealing with a matter affecting one of the following officers, the Chief Executive, the Council's Section 151 Officer and/or the Monitoring Officer, either the Employment Procedure Committee and/or the Appeals Committee (as necessary) can consist solely of independent members if that is so resolved by ordinary Council Members of the relevant Committee"
