# ENGAGEMENT AND CONSULTATION PROCESS

- Engagement and consultation panel
- Overview and scrutiny committee
- Over 1600 questionnaires returned
- 15 Public consultation events held alongside meetings with Governors and HT, including SEND parent carers
- Website continuously updated and social media use including capturing comments
- Use of children and family centres and encouraged to complete questionnaires
- Radio





## WHAT ARE THE PROPOSALS ?

- Introduce a 0-19 offer
- Sustain and expand outreach
- Address duplication on early years/help by transferring this to Children centres
- Introduce 3 Family and Well Being Centres; Talbot, Waterloo Primary and Netherton (which is already a colocated Family and Children Centre)
- Provide 9 complimentary bases
- Re-locate Seaforth Family and Children centre building





# PUBLIC RESPONSE AND KEY CONSULTATION THEMES

- Anxious about closures with some focus on the North of the Borough as well as Seaforth
- "Done deals" and communities within communities
- Transport accessibility buses, buggies and parking
- Support for disability/BME and families from around the World and barriers
- Significant locality opposition to Talbot Street and Waterloo
- 80% agree with key principles but 63% against 3 Family and Well Being centres and complimentary bases
- GPs and health are very keen to work together to establish Health and Wellbeing Centres
- Some Centres who weren't proposed for Family and Wellbeing Centres suggested that they become a Family and Wellbeing Centre





## You said...we listened – revised proposals

- Children Centres to support 0-19, early years, sustain and expand outreach and provide all early help services to avoid duplication; and introduce new funding methodology.
- keep Seaforth where it is
- Stage 2 would develop Health and Wellbeing services within the next 2 years





## MONEY

- £169 million saved since 2011 and a further £64 million to save by 2020
- This proposal will save Circa £1.5M
- Funding methodology which ensures equity and transparency and considers
  - the Income Deprivation Affecting Children Index (IDACI), which is also used locally to allocate some school funding
  - inequalities in particular disability, migrants (English as a Second Language), travellers
  - reach footprints
  - the number of new births
  - an indication of the percentage of children in an area requiring social care support
  - case weighting for children in need and looked after children
  - a minimum funding protection factor that ensures no centre will see a reduction in funding by more than 31% of its historical funding.
