1. Introduction/Background

- 1.1 On 3 December 2022, an application was made for the introduction of a Disabled Parking Place (DPP) associated with 187 Seaforth Road, Seaforth.
- 1.2 As part of Sefton's procedures, the applicant supplied a completed application form, detailing her disability and the vehicle details she uses to transport her together with copies of her blue badge.
- 1.3 These details were checked, and a number of parking surveys carried out to establish the level of parking within the vicinity of the applicants' property.
- 1.4 The application satisfied all criteria for the provision of a Disabled Parking Space, and the parking surveys clarified that there were never any spare parking spaces available at peak times.
- 1.5 The application was approved, and authorisation sought from Cabinet Member – Locality Services to advertise the proposed Traffic Regulation Order. The proposal was subsequently advertised in The Metro newspaper on 11th February 2023, with a 21 day objection period ending on 1st March 2023.
- 1.6 One objection was received during the objection period.
- 1.7 The objection is listed below, with various sections redacted to maintain confidentiality:-

I would like to formally reject the proposal to have a disabled parking spot next to my house. I also have a car and the proposal means that she will encroach my house.

The lady who lives in 187 seaforth road doesn't even own a car. The car is her daughters who works full time. She just wants a disabled space because she thinks she owns the street and sometimes people park there. If you would like to speak to me, my number is [REDACTED]

2.0 Discussion

Given that the applicant has met all the criteria for the application of the disabled persons parking place. The vehicle which transports the applicant is registered at the applicants address and the availability for parking space for the applicant is restricted, there is no reason for the parking place not to be implemented.

3.0 Proposal

- 3.1 Under the constitution of this Committee, Members can either:-
 - a) approve the parking place as proposed, or;
 - b) reject the parking place or;
 - c) refer the scheme to the Cabinet Member Locality Services indicating the Committee's view on how the proposal should be progressed.

- 3.2 Having reviewed the applicant's supporting documentation and the situation with regards to the parking situation on-street, it is considered that Licensing & Regulatory Members should be minded to over-rule the objection and the proposed Disabled Parking Place be progressed as originally advertised.

1. Details of licensing applications accepted for process

- 1.1 During the period 1 April 2022 to 31 March 2023 865 applications were accepted for process under the Licensing Act 2003 (“the LA03”), this representing a 19.5% increase over the 726 applications received during the equivalent 12-month period for 2021/2022.
- 1.2 Under the Gambling Act 2005 (“the GA05”), 20 applications were accepted for process, this representing a 58% decrease over the 47 applications received during the equivalent 12-month period for 2021/2022.
- 1.3 With respect to general licensing applications (animal welfare, scrap metal dealers, personal treatment registrations etc.), 114 applications were received, this representing a 9.5% decrease over the 126 applications received during the equivalent 12-month period for 2021/2022.
- 1.4 With respect to applications for street collection permits, 46 applications were received, this representing a 2.2% increase over the 45 applications received during the equivalent 12-month period for 2021/2022.
- 1.5 With respect to applications for house to house collection permits, 26 applications were received, this representing a 8.3% increase over the 24 applications received during the equivalent 12-month period for 2021/2022.

2. Advertisement of certain LA03 applications

2.1 In order to ensure that Grant and Variation applications are brought to residents' / businesses' attention, since 25 April 2012 (via legislation introduced into the LA03 by The Police Reform and Social Responsibility Act 2011) the Licensing Unit has been required to advertise these types of applications on the Council website (this is in addition to the existing provisions which were retained whereby the applicant has to advertise the application in a newspaper and on the premises).

2.2 In respect of Sefton these Notices can be found via a dedicated page on the Council website via:

www.sefton.gov.uk/business/licensing-registration/entertainment,-alcohol-and-late-night-refreshment/licensing-act-public-notice.aspx.

2.3 During the relevant period there were 68 applications received which required such advertisement; these comprised of 51 Grant applications and 17 Variation applications, this representing a 14% decrease over the 79 applications received during the equivalent 12-month period for 2021/2022.

3. Sefton's LA03 leafleting notification scheme

3.1 This scheme was formally adopted by Members at their Meeting on 6 June 2011. The scheme involves the Licensing Unit going over and above the advertising provisions of the LA03 by proactively informing those occupiers and owners of properties with curtilages abutting premises, who have made certain applications under the LA03, of the fact of that application.

3.2 As a consequence Licensing Officers sent out a total of 347 notifications to residents / businesses; the average being 5 notifications sent per application.

3.3 The Licensing Unit received no objections from residents / businesses leafleted as a direct result of this activity.

4. Reports submitted to Licensing Sub-Committee

4.1 During the relevant period 16 Reports were submitted by the Unit for consideration by the Licensing Sub-Committee, this representing a 78% increase over the 9 Reports submitted during the equivalent 12-month period for 2021/2022.

5. Details of Reviews held

5.1 During the relevant period 1 premise licence review application was dealt with, this representing a 50% decrease over the 2 reviews dealt with during the equivalent 12-month period for 2021/2022.

6. Details of LA03 Licences surrendered

6.1 At their Meeting on 19 November 2012 Members RESOLVED that any future Performance Reports should "*provide details of surrendered Licences*".

6.2 During the period 1 April 2022 to 31 March 2023 24 Licences were surrendered, this representing a 4% decrease over the 25 Licences which were surrendered during the equivalent 12-month period for 2021/2022.

7. Details of Service Requests received

7.1 During the relevant period the Unit received and dealt with 1,103 service requests. This representing a 10.08% increase over the 1,002 service requests received during the equivalent 12-month period for 2021/2022. Of these 10 took the form of LA03 complaints, whilst 13 were general licensing complaints.

7.2 With regard to the Doorman Logbooks the Unit dealt with 14 request for Logbooks to be dispatched.

7.3 The following were service requests to the Unit for guidance, advice or information: 781 under the LA03, 16 under the GA05, with 269 under general licensing.

7.4 All of the above matters were attended to within the departmental timescales laid down for such matters.
