6. Tariff 2 Fare Structure Changes

Mr. Crabtree (NSHCA), Mr. Bridson (NWTA) and Mr. Murrison (SSTA) requested that the Committee consider the proposal of a restructure in the hackney carriage / private hire fare, involving an increase by 1 hour at Tariff 2 between 05.00 and 06.00 hours.

A letter from Mr Bridson is attached in support of this proposal.

National Vocational Qualification (NVQ) / Vocationally Related Qualification (VRQ) -'Funding and Grandfather Rights'

Item requested by Mr. Crabtree (NSHCA) and Mr. Murrison (SSTA) in respect of

- (a) individual funding for for NVQ's /VRQ's a number of drivers are not entitled to receive 'Train to Gain' funding;
- (b) 'Grandfather Rights' request that drivers who have worked continuously in the hackney carriage / private hire trade for a given number of years (e.g. 10 or more) be exempt from the requirement to undertake NVQ / VRQ training.

8. Airport Transport Companies

Mr. Crabtree (NSHCA) requested this item because of concern that Airport Transport Companies do not display private hire plates on their vehicles and are not required to undertake Criminal Records Bureau (CRB) checks.

Request by Mr. Crabtree (NSHCA), for an additional hackney carriage and private hire vehicle testing station in the Southport area.
