47. APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors Hands, D.Rimmer and C.Mainey.

48. DECLARATIONS OF INTEREST

No declarations of interest were received.

49. MINUTES

RESOLVED:

That the minutes of the meeting held on 26 October 2009 be confirmed as a correct record.

50. PETITION - DE-RESTRICTION OF HACKNEY CARRIAGE LICENCE PLATES

The Committee considered a petition submitted in accordance with Rule No. 27 of the Council and Committee Procedure Rules of the Constitution, from Mr D Smith expressing concern in relation to Sefton Council's policy of restricting the number of hackney carriage vehicle licences.

Mr D. Smith attended the meeting in support of the terms of the petition.

RESOLVED:

That the petition be noted.

51. PETITION - HACKNEY CARRIAGE VEHICLE LICENCES DE-RESTRICTION

The Committee considered a petition submitted in accordance with Rule No. 27 of the Council and Committee Procedure Rules of the Constitution, from Mr R Jarman in support of the Local Authority's current policy on numerical restriction of Hackney Carriage Vehicle Licences.

Mr R. Jarman addressed to meeting in support of the terms of the petition.

RESOLVED:

52. PETITION - HACKNEY CARRIAGE VEHICLE LICENCES DE-RESTRICTION

The Committee considered a petition submitted in accordance with Rule No. 27 of the Council and Committee Procedure Rules of the Constitution, from Mr T Crabtree in support of the Local Authority's current policy on numerical restriction of Hackney Carriage Vehicle Licences.

Mr M.England addressed the Committee in support of the terms of the petition.

RESOLVED:

53. DETERMINATIONS UNDER THE LICENSING ACT 2003: PERIOD COVERING 10 OCTOBER 2009 TO 6 NOVEMBER 2009

The Committee considered the report of the Environmental Protection Director updating on the applications made under the Licensing Act, 2003 which he had determined.

The report indicated that Sefton's Statement of Licensing Policy followed the recommended delegation of functions contained within the "Guidance issued under Section 182 of the Licensing Act 2003"; that in effect, this meant that where there were no relevant representations on an application for the grant of a premises licence or club premises certificate, or Police objections to an application for a personal licence, then these matters would be dealt with by Officers in order to speed matters through the system; and that the Guidance also recommended that, where powers had been delegated, the Committee would receive regular reports on decisions made so that they maintained an overview of the general licensing situation.

For the period 10 October 2009 to 6 November 2009 the Environmental Protection Director had received and determined 48 applications for Premises Licences; 13 applications for Personal Licences and 17 notifications of Temporary Events Notices.

54. DETERMINATIONS UNDER THE GAMBLING ACT 2005: PERIOD COVERING 10 OCTOBER 2009 TO 6 NOVEMBER 2009

The Committee considered the report of the Environmental Protection Director, updating on the applications, made under the Gambling Act 2005, which he had determined.

The report indicated that Sefton's Statement of Licensing Policy followed the recommended delegation of functions contained within the "Guidance issued under Section 25 of the Gambling Act 2005"; that in effect, this meant that where there were no relevant representations on an application for the grant of a premises licence or a permit then these matters would be dealt with by Officers in order to speed matters through the system; and that the Guidance also recommended that, where powers had been delegated, the Committee would receive regular reports on decisions made so that they maintained an overview of the general gambling situation.

For the period 10 October 2009 to 6 November 2009 the Environmental Protection Director had received and determined 11 applications for Licensed Premises for Automatic Gaming.

RESOLVED:

That the report and the fact that further update reports would be submitted, as necessary, be noted.

55. RESULTS OF SEFTON LICENSING SURVEY 2008

Further to Minute No 32 of the meeting held on 28 September 2009, the Committee considered the report of the Environmental Protection Director on the results of the Sefton Licensing Survey undertaken by Mott MacDonald; indicating that the Committee had requested that this paper be considered in conjunction with the findings and recommendations contained within the Community Involvement – Licensing Act Working Group report of the Overview and Scrutiny Committee (Regeneration and Environmental Services); and that Mott MacDonald had been commissioned to gauge how the "notification system" for local residents (including the applicants themselves) perceived the Act to be working in relation to reviews, grants, variations or minor variations.

The Licensing Unit provided addresses of 55 premises that had (within 6 months of the commencement of the Survey in March 2008):

(1) had a review of a Premises Licence or Club Premises Certificate;

(2) applied for a new Premises Licence or Club Premises Certificate; or,

(3) applied for a variation of a Premises Licence or Club Premises Certificate.

Some 3,538 addresses were then selected by Mott MacDonald that were adjacent to the premises or within 50 metres of the boundary of the premises in question; these addresses included both residential and commercial properties and adjacent properties which had a common boundary with the premises and could be considered as being "interested parties" under the Act.

Three separate questionnaires were designed in conjunction with Mott MacDonald and the Licensing Unit and sent, along with a covering letter, to licence applicants, respondents in close proximity to a premises that had been subject to a Licence Review and to those close to premises that had applied for a new licence or a variation to a licence (the "Grants/Variations Survey").

Attached as appendices to the report were copies of the questionnaires, covering letters and a report indicating the results of the survey.

56. COMMUNITY INVOLVEMENT - LICENSING ACT WORKING GROUP

Further to Minute No 24 (4) of the Overview and Scrutiny Committee (Regeneration and Environmental Services) meeting held on 15 September 2009, the Committee considered the report of the Legal Director presenting the final report of the Community Involvement - Licensing Act Working Group.

The Overview and Scrutiny Committee had resolved that:

- (1) the Chair, in consultation with the Overview and Scrutiny Officer be authorised to amend the final report accordingly as a result of comments from this meeting;
- (2) the final report and recommendations detailed in paragraph 9.0 be agreed;
- (3) the final report be referred to the Public Engagement and Consultation Standards Panel for its consideration and comment;
- (4) the final report, together with any comments from the Public Engagement and Consultation Standards Panel be referred to Licensing and Regulatory Committee for consideration and comment.
- (5) the final report be referred to the Overview and Scrutiny Committee (Performance and Corporate Services) for information; and

(6) the final report together, with any comments from the Licensing and Regulatory Committee and the Public Engagement and Consultation Standards Panel be referred to Cabinet for further consideration.

Attached as an Annex to the report was a copy of the Community Involvement – Licensing Act Working Group final report; and the views of the Committee were sought thereon.

It was agreed that whilst the implementation of the recommendations within Community Involvement - Licensing Act Working Group report may potentially have resources implications, and would need to be monitored throughout the trial period, greater public engagement should be welcomed.

RESOLVED: That Cabinet be requested:

- (1) to endorse the recommendations in paragraph 9.0 of the report of the final report; and
- (2) if so minded, to approve the recommendations in paragraph 9 of the report, refer their decision to all Area Committees for information.

57. LOCAL LICENSING: HALF YEAR PERFORMANCE REPORT 2009/10

Further to Minute No. 51 of the meeting held on 20 April 2009, the Committee considered the report of the Environmental Protection Director updating on the programmed inspection regime for those premises licensed under the Licensing Act 2003 and the Gambling Act 2005.

The report indicated that, under the Licensing Act 2003, 170 premises had been inspected between 1 April 2009 and 30 September 2009; that 103 were found to be operating correctly and that 67 were found to have committed various breaches under the Licensing Act 2003, and detailed such breaches. Most premises were able to attend to the breaches at the time of the initial visits and whilst the Licensing Officer was still in attendance.

The report indicated that, under the Gambling Act 2005, 46 premises had been inspected between 1 April 2008 to 31 March 2009; that 20 premises were found to be operating correctly and that 11 premises were found to have committed various breaches and detailed such breaches. All premises were able to attend to the breaches at the time of the initial visits and whilst the Licensing Officer was still in attendance.

The report concluded by detailing that the Licensing Unit had received 270 Service Requests and that such requests were handled in accordance with departmental timescales.

It was clarified that the targets for inspections were set by the Environmental Protection Department based on a desktop exercise; that some inspections were rolled over from last year due to long term sickness absence and a vacancy freeze; that these issues were being addressed; and that whilst the Environmental Protection Director was confident of meeting inspection targets for all premises in category A, some licensed premises in category B could be rolled over to next year.

RESOLVED:

- (1) that the report and the fact that further update reports will be submitted, as necessary, be noted; and
- (2) the Environmental Protection Director be requested to produce a report regarding the regulation of tanning salons within the Borough.

58. TAXI LICENSING: HALF YEAR PERFORMANCE REPORT 2009/10

Further to Minute No 52 of the meeting held on 20 April 2009, the Committee considered the report of the Environmental Protection Director that provided an update service performance in relation to Taxi Licensing for the period 1 April 2009 to September 2009.

RESOLVED: That

- (1) the report, and that further update reports would be submitted on a bi-annual basis, be noted; and
- (2) the attendance and pass rates of taxi licensing knowledge tests be raised with the representatives of the Hackney Carriage/Private Hire Joint Working Group.

59. THE ROAD TRAFFIC VEHICLE (VEHICLE EMISSIONS) (FIXED PENALTY) (ENGLAND) REGULATIONS 2002

The Committee considered the report of the Environmental Protection Director seeking approval for the adoption of Section 6 of the Road Traffic (Vehicle Emissions) (Fixed Penalty) (England) Regulations 2002 (the Regulations) to be better able to respond to concerns about air pollution, fumes and odours caused by stationary vehicles left with their engines idling; and for the delegation of the powers to the Environmental Protection Director to utilise such powers; and indicating that a decision on this matter was required as the Council's current constitution required both the Licensing and Regulatory Committee and the Cabinet Member -Environmental to approve the adoption of this legislation and delegation of the relevant powers in order for officers to utilise them.

The report indicated that the Regulations were introduced to support Local Air Quality Management and the achievement of the National Air Quality

Strategy objectives; and concluded that adoption of Part 6 of the Regulations would give Environmental Protection Department officers the necessary legislative backing to pursue incidents of stationary vehicles leaving their engines running where persuasive methods had failed; that reference to a legal requirement would assist enforcement and increase the chance of persuasive methods succeeding; and that it was proposed that powers be delegated to the Environmental Protection Director to enable him to authorise appropriate officers. The powers would therefore be used to strengthen the approach of Environmental Protection Department Officers when dealing with complaints about operators and drivers.

RESOLVED: That

- (1) the adoption of Part 6 of the Road Traffic (Vehicle Emissions) (Fixed Penalty) (England) Regulations 2002 be approved; and
- (2) the Council be recommended to amend the Responsibility of Functions of the Constitution by addition of the following delegation to the Environmental Protection Director

- C. Environmental Protection Director
- 20. Authority to enforce the powers contained in Part 6 of the Road Traffic (Vehicle Emissions) (Fixed Penalty) (England) Regulations 2002."

60. CHARITIES ACT 2006 - CONTROL OF CHARITY COLLECTORS

Further to Minute No 75 of the Southport Area Committee meeting held on 30 September 2009 the Licensing and Regulatory Committee considered the report of the Legal Director on the Charities Act 2006 - Control of Charity Collectors; indicating that concern had been raised by residents regarding the "aggressive" form of charity collection on Chapel Street, Southport; that whilst the Local Authority was able to issue and regulate Street Collection Licenses under Section 5 of the Police Factories etc (Miscellaneous Provisions) Act 1916, as amended by the Local Government Act, 1972, Schedule 29, as the rules dated back to 1916, i.e. prior to direct debit, standing orders and credit card donations, the Local Authority had no powers to regulate "professional fundraisers" who collected direct debit mandates etc; and that as further powers to help address this issue would be part of the Part 3 of the Charities Act which has yet to be rolled out, the Committee be requested to approve the content of the letter attached as an annex to the report from the Legal Director, on behalf of the Local Authority, to the Office of the Third Sector to request that the implementation of Part 3 of the Charities Act be completed as soon as possible.

Background

- 1. Members will recall that Section 5 of the Licensing Act 2003 ("the Act") requires that the Licensing Authority has to prepare and publish a statement of its licensing policy ("the Policy") every three years. During this three year period, the Policy must be kept under review and the Licensing Authority may make such revisions to it as it considers appropriate, for instance in the light of feedback from the chief officer of police, on whether the statutory four licensing objectives are being met.
- 2. The existing Policy has been kept under review since coming into force on 7th January 2008 and no revision has been deemed necessary to date. However, the Policy will require revising during 2010 in order for it to take effect from 7th January 2011 (when the new three year cycle will commence).
- 3. Before determining its Policy for any three year period, the Licensing Authority must consult the persons listed in Section 5(3) of the Act. Those being:
 - (a) the chief officer of police for the area;
 - (b) the fire authority for the area;
 - (c) persons/bodies representative of local holders of premises licences;
 - (d) persons/bodies representative of local holders of club premises certificates;
 - (e) persons/bodies representative of local holders of personal licences; and,
 - (f) persons/bodies representative of businesses and residents in its area.
- 4. The views of the above have to be given appropriate weight when the Policy is being determined.

- First draft presented to Members for comment

Background

- 1. The harmful effects of ultraviolet radiation have been known for many years. Whilst natural sunshine remains the biggest source, the use of ultraviolet devices such as sunlamps, sunbeds and tanning booths can significantly increase exposure. The injuries caused by ultraviolet radiation can be both short term, e.g. sunburnt skin or conjunctivitis, and long-term e.g. premature skin ageing, cataracts and skin cancer.
- 2. In 2006 the Scientific Committee on Consumer Products reported to the European Commission that in Britain an estimated 100 deaths occurred each year as a result of sunbed use. The Health and Safety Executive (HSE) has also stated that exposure before the age of 35 can significantly increase the risk of several types of skin cancer.
- 3. Recently, sensitivity on this issue has been heightened in the general population following a series of high profile cases of individuals being injured whilst using equipment. Two of the most serious cases occurred in Wales. Firstly, a 10 year old was seriously burned in Port Talbot after spending just 16 minutes on a sunbed at an unsupervised salon, and secondly a 14-year-old girl had to be rushed to hospital after suffering first-degree burns to 70% of her body. She had spent only 19 minutes on a sunbed in an unstaffed salon in Barry.
- 4. The growing acceptance of the damage that these appliances can cause, combined with these high profile incidents, has led to calls for tougher legislation from several quarters.

The Current Regulatory Position

- 5. The Government has indicated its desire to strengthen legislation in this area. England is lagging behind the rest of the UK as devolved administrations have recently taken action. The only legislation which applies in England is the Health and Safety at Work Act 1974 and the Management of Health and Safety at Work Regulations 1999. This legislation applies to all workplaces, not just sunbed centres. Therefore, it is quite general in nature and open to wide interpretation. No licensing regime exists in Sefton.
- 6. The HSE has recently reviewed its guidance and produced "Reducing health Risks from the use of Ultraviolet (UV) Tanning Equipment". This guidance summarises the current legal position and provides detail of accepted good practice when operating a sunbed business. The guidance is attached as Annex 1.
- 7. Scotland now has specific legislation. The Public Health etc (Scotland) Act 2008 regulates the use of UV tanning equipment. It is now illegal in Scotland to have unstaffed coin-operated facilities or to allow under 18s to use equipment.

- 8. In Wales, as a result of the above-mentioned tragedies, the National Assembly is currently considering introducing similar legislation. The Inquiry into these tragedies reported that while there is no wholly safe dosage, children and young people are particularly at risk. It concluded that the current regulatory framework provides insufficient safeguards against misuse.
- 9. The Health Minister in Northern Ireland has recently launched a consultation into the regulation of the sunbed industry. This is clearly being done with the intention of introducing similar legislation to the Scottish model.


The Situation In Sefton

10. The situation in Sefton is no different to other areas of England, in that the generic legislation exists. However, because of the growing public concern on this issue the Health and Safety Team, within the Environmental Protection Department, have included a project on sunbed safety in its work programme for 2010/11. The project is designed to visit all establishments to ensure compliance with the current legislation and promote good practice amongst the trade. It will also place the Department in an excellent position to act when the Government eventually introduces appropriate legislation for this sector, in that a high level of intelligence, in relation to business performance, will already exist.

Reducing health risks from the use of ultraviolet (UV) tanning equipment



This is a web-friendly version of leaflet INDG209(rev1), revised 04/09

Introduction

The use of any ultraviolet (UV) tanning equipment (eg sunlamps, sunbeds and tanning booths) may expose staff and will expose customers to UV radiation. UV radiation can cause injuries and ill health either in the short term (eg sunburnt skin or conjunctivitis) or in the long term (eg premature skin ageing, skin cancer and cataracts). Exposure to UV radiation tanning equipment before the age of 35 years significantly increases the risk of several types of skin cancer. Younger people seem to be more at risk from the cancer causing effects of indoor tanning.¹

HSE considers the advice in this leaflet to reflect good practice for employers operating UV tanning equipment. This leaflet gives advice on how to reduce health risks.

Operators should note that the Public Health etc (Scotland) Act 2008 regulates the use of UV tanning equipment in Scotland. Scottish operators will need to consider these legal requirements over and above the advice in this guidance. More information about these Scottish laws can be found at www.opsi.gov.uk/ legislation. Some English local councils and local authorities in Scotland also have licensing requirements for UV tanning equipment, so operators must make sure they are meeting local, legal requirements too.

This guidance contains general information for people who are responsible for operating UV tanning facilities. Specific advice for customers based on current expert medical opinion, is given on the poster *UV tanning equipment*.

This leaflet only explains the health hazards of UV radiation as they are understood at the moment. It does not give a list of all hazards found with operating UV tanning equipment. For advice on other risks that could be encountered while operating UV tanning equipment, eg electrical safety, manual handling or general health and safety information, see the HSE website at www.hse.gov.uk and the documents detailed at the end of the leaflet.²⁻⁴

Information for UV tanning equipment operators

Legal responsibilities

Under the Health and Safety at Work etc Act 1974 (HSWA)⁵ and the Management of Health and Safety at Work Regulations 1999 (MHSWR),⁶ you, the UV tanning equipment operator, must:

- assess the risks caused by your work activity including those from exposure to UV radiation;
 - take measures Page 69 as is reasonably practicable, the risks;

- tell your staff the results of your risk assessment. Make sure they are trained and competent in the operation and use of any tanning equipment; and
- if you have five or more employees you must write down the main findings of the assessment.

Carrying out the risk assessment is your responsibility though you can seek help and advice, from within your organisation or outside sources (eg consultants).

The Approved Code of Practice Management of health and safety at work: Management of Health and Safety at Work Regulations 1999⁶ contains further information about legal responsibilities under the HSWA and MHSWR.

Assessing the risk of using UV tanning equipment

The purpose of your risk assessment is to help you make an appropriate decision about what you need to do to prevent or control UV radiation exposure levels to people working near or using your UV tanning equipment.

A risk assessment does not need to be long or complex, but you do need to work through the following five steps:

- Identify the hazards.
- Decide who may be harmed and how.
- Work out the risks and decide on actions.
- Record your findings (if you employ five or more people) and act on them.
- Review and monitor your risk assessment and regularly update it if necessary.

HSE's leaflet *Five steps to risk assessment*² gives straightforward advice. HSE also publishes example risk assessments to show what is expected. Both can be found at www.hse.gov.uk/risk.

The consequences of exposure to the hazard of UV radiation, which can be associated with running and/or using UV tanning equipment, are as follows.

Short-term effects

- Burns.
- Skin dryness and itching.
- Eye irritation or conjunctivitis (where suitable goggles are not worn).
- Customers becoming trapped if the equipment fails mechanically.

Long-term effects

- Skin cancer.⁷⁻⁸
- Cataracts (where suitable goggles are not worn).
- Premature ageing of the skin, which will look coarse, leathery and wrinkled.

Who might be at risk?

You need to consider:

- employees assisting customers;
- maintenance staff carrying out repairs or servicing;
- the customers using the equipment; and
- other members of the public (adults and under-18s) on the premises.

You must inform your employees of the risk of operating and using UV tanning equipment. To control the risk of exposure to UV radiation to your customers, we advise you to provi

Operating your UV tanning equipment safely

Following the advice in this section will help you to address the risks associated with using UV tanning equipment. However, this is not a complete list and as a result of your risk assessment, you may have identified other things that need to be done.

- You should have received information from the manufacturer or supplier on the correct operation of your UV tanning equipment, and should have familiarised yourself and any employees with it, and be following it. This information should include the correct lamps to use and the maintenance regime.
- It is good practice to have trained staff present while customers are using your UV tanning equipment.
- You should provide ongoing health and safety training for your staff to make sure they can correctly run the equipment, provide customers with information about the risks and assist as required.
- It is good practice that you have effective procedures in place to provide immediate assistance to customers using your UV tanning equipment.
- Make sure that children (under 18 years of age) accompanying adults, who are using UV tanning equipment, are not exposed to UV radiation.
- If you are operating more than one piece of equipment in the same room, you are recommended to use screening between the units.
- It is good practice that you make sure the equipment is cleaned and sanitised between customers.
- When you are replacing UV tubes make sure the right type are fitted and reassess the exposure requirements of your customers when subsequently using the equipment. The BS EN standard on manufacturing UV tanning equipment should provide more useful information.⁹
- Make sure your staff are aware of the risks to themselves from working with UV tanning equipment and how to reduce or avoid these risks.
- It is good practice to keep training records for your staff.
- It is good practice that you provide adequate eye protection (goggles) for customers and staff, when maintaining equipment.
- When carrying out your risk assessment, you are advised to consider the advice of the World Health Organization and EU Scientific Committee on Consumer Products who have recommended that under-18s should never use UV tanning equipment. Background

- In respect of hackney carriage & private hire vehicle licensing, the Council is currently authorised by the DfT Vehicle Inspectorate Agency to test vehicles under a Compliance Testing Scheme in accordance with the Motor Vehicles (Test) Regulations 1981 (as amended). The current certification was obtained on 8th July 1998.
- 2. The authorisation requires Sefton Metropolitan Borough Council to only appoint testing facilities which are Vehicle and Operator Services Agency (VOSA) approved "MOT" facilities. In addition the Local Government (Misc. Provisions) Act 1976 requires the Council to only appoint facilities that are based within the political boundary as the Council can only require vehicles to be tested at facilities which are within the area of the Council.
- 3. The use of this compliance scheme means that, in addition to the standard "MOT" test, the Council can specify additional items which it considers necessary to safeguard the best interests of the travelling public of Sefton.
- 4. In 1998 the Council licensed a total of 1673 hackney carriages and private hire vehicles. At that time, there were three testing facilities, Virginia Street, Southport, Hidderley's, Bootle and Beach Garage, Seaforth. For reasons of consistency of testing, the Council then determined that only in the event that undue delays in obtaining a test appointment were encountered would other facilities be required.
- 5. In 2002 the Council's own facility at Pine Grove in Bootle was added to the list of appointed facilities making a total of four stations. However since that facility moved to Hawthorne Road in 2006 the "MOT" authorisation has lapsed. Thus the original three facilities have dealt with all of Sefton Council's motor vehicle compliance tests since 2006.
- 6. There are currently approximately 2910 licensed private hire and hackney carriage vehicles which are licensed by Sefton. This is an increase of 74% over the earlier 1998 figure of 1673 vehicles. The burden of coping with this increased demand for compliance testing has fallen on the existing testing facilities.
- 7. Consequently the trade is reporting there are now delays on up to four days in putting vehicles through a test which is leading to some commercial disadvantage. There have also been longstanding requests from Stakeholders requesting another facility in the North of the Borough

8. At the Trade Stakeholder Meeting, 8th December 2009, the group discussed the current facilities for the testing of hackney carriage and private hire vehicles. The discussion focused on the current inadequacy of the current testing provisions and highlighted the delays now being experienced by

vehicle licence applicants. It was suggested that a three to four day delay was now becoming common.

- 9. One of the Trade Stakeholders present, Mr Johnson, the owner of Tyre Express Garages Services Ltd, 22 Berry Street, Bootle L20 8AT indicated that he owned an authorised "MOT" testing facility and wished to apply to test vehicles prior to licensing.
- 10. The group also considered whether any limitation should be placed on Tyre Express Garages Services Ltd in respect of being able to test Mr Johnson's own fleet of hackney carriage / private hire vehicles. The Group agreed that should Tyre Express Garages Services Ltd submit an application for test station status, the Group would support the application without condition because of the immediate need for more testing capacity.

Issues For Consideration

- 11. On the 9th December 2009 Tyre Express Garages Services Ltd submitted an application to act as a Council testing facility as attached at Annex A to this report.
- 12. The appointment of the Council's testing facilities has historically been reserved to the Licensing & Regulatory Committee and the determination of the Committee is requested.

Background

- 1. Members will recall that at their Meeting on 23rd November 2009 they considered the Overview and Scrutiny Report entitled "Community Involvement Licensing Act Working Group", it was RESOLVED that Cabinet be requested:
 - (i) to endorse the recommendations in paragraph 9.0 of the report of the final report;

and,

- (ii) if so minded, to approve the recommendations in paragraph 9 of the report, refer their decision to all Area Committees for information.
- 2. At their Meeting on 17th December 2009, Cabinet considered this matter and RESOLVED:
 - That the recommendations set out in Paragraph 9 of the report be approved and be referred to all Area Committees for information.
- 3. The recommendations referred to in 1.(1) and 2. above being:
 - That those occupiers and owners of properties with curtilages abutting those premises applying for a Premises Licence, Club Premises Certificate, the Variation of a Premises Licence or Club Premises Certificate or any Premises subject to a review, be notified of any such application.
 - Any such Borough-Wide notification procedure to be adopted for a 12 month period with the results of the pilot being the subject of a further report to the Licensing and Regulatory Committee to consider whether the scheme of notification be continued/enhanced/withdrawn, as appropriate prior to the full review of Sefton's Statement of Licensing Policy for 2011.
 - That the Report in relation to the outcomes of the Borough-Wide pilot on notification be submitted to the Overview and Scrutiny Committee (Regeneration and Environmental Services) for information.

Trial Leafleting Scheme Details

- 4. It is proposed that the Leafleting Scheme will commence on 1st April 2010 and will run up to and include 31st March 2011 and will be Borough wide.
- 5. This timeframe covers the full licensing inspection year for 2010 / 2011 and as such will enable comparisons to be drawn directly with regard to any impact the Scheme may have on:
 - the inspection regimes (for both Licensing Act 2003 and Gambling Act 2005 premises);

- (ii) the answering of and dealing with service requests; and,
- (iii) the other statutory licensing work of the Section.
- 6. The 1st April commencement will enable the setting up of the new processes involved as well as the purchase of the appropriate computer mapping software.
- 7. The Statement of Licensing Policy will require revising during 2010, in order for it to take effect from 7th January 2011, and it will need to include mention of the Leafleting Scheme. It is proposed, therefore, to include the following new Paragraph 5.11:

The Licensing Authority will notify those residential and business properties with curtilages abutting those premises applying for a Premises Licence or a Club Premises Certificate, the Variation of a Premises Licence or Club Premises Certificate, or any premises subject to a review. Whilst this is not a statutory requirement, the Licensing Authority is of the belief that it is important to ensure that the community are fully aware of licensing applications made in their area and as such this will ensure that local people have a voice in licensing decisions. All Councillors will be notified of any such applications received.

- 8. The revision of the Policy will be the subject of separate update Reports to the Committee throughout the year.
- 9. A copy of the proposed leaflet to be used in respect of Grant / Variation applications can be found within Annex 1 to this Report and the proposed leaflet to be used for Reviews can be found within Annex 2.
- 10. Both leaflets have been drafted with a view to being as neutral in tone as possible in order to avoid any accusations that the Licensing Authority is in fact "trawling for objections".
- 11. The leaflets will inform residents of the type of application that has been made and of the various ways in which they may obtain further details of the application.
- 12. These being obtained from:
 - (i) the Sefton Council Website (via the Licensing Register pages or the Review page dependant upon the application);
 - (ii) Sefton Plus Contact Centre; or,
 - (iii) by making an appointment to view the application itself at the Licensing Section's Offices.

These being similar to the processes used under the Planning model.

13. Should residents require detailed information on how they can submit representations (either for or against an application), or indeed should they have any other questions that the Contact Centre cannot assist with, the direct line of the Licensing Officer dealing with the case will also be included on the leaflet.
