1. APOLOGIES FOR ABSENCE

RESOLVED:

That the Minutes of the meeting held on 19 April 2010 be confirmed as an correct record.

4. THANK YOU TO FORMER COUNCILLOR MARK BIGLEY

The Committee asked that their thanks be passed to former Councillor Mark Bigley for his contribution as former Chair of the Committee.

5. LOCAL LICENSING: PERFORMANCE REPORT 2009/10

Further to Minute No. 57 of the meeting held on 11 November 2009, the Committee considered the report of the Environmental and Technical Services Director on the programmed inspection regime for those premises licensed under the Licensing Act 2003 and the Gambling Act 2005.

The report indicated that, under the Licensing Act 2003, 192 premises had been inspected between 1 October 2009 and 31 March 2010; that 132 premises were found to be operating correctly and that 76 premises were found to have committed various breaches under the Licensing Act 2003, and detailed such breaches. Most premises were able to attend to the breaches at the time of the initial visits and whilst the Licensing Officer was still in attendance.

The report indicated that, under the Gambling Act 2005, 43 premises had been inspected between 1 October 2009 to 31 March 2010; that 36 premises were found to be operating correctly and that 7 premises were found to have committed various breaches and detailed such breaches. All premises were able to attend to the breaches at the time of the initial visits and whilst the Licensing Officer was still in attendance.

The report, concluded by detailing that the Licensing Unit had received 411 Service Requests and that such requests were handled in accordance with departmental timescales.

RESOLVED: That

- (1) the report and the fact that further update reports will be submitted, as necessary, be noted; and
- (2) a report in relation to the criteria used to categorise the number and frequency of inspections for all premises be brought to the next appropriate Committee for Members' consideration.

6. DETERMINATIONS MADE UNDER THE LICENSING ACT 2003: PERIOD COVERING 1 APRIL 2010 TO 21 MAY 2010

The Committee considered the report of the Environmental and Technical Services Director updating on the applications made under the Licensing Act, 2003 which he had determined.

The report indicated that Sefton's Statement of Licensing Policy followed the recommended delegation of functions contained within the "Guidance issued under Section 182 of the Licensing Act 2003"; that in effect, this meant that where there were no relevant representations on an application for the grant of a premises licence or club premises certificate, or Police objections to an application for a personal licence, then these matters would be dealt with by Officers in order to speed matters through the system; and that the Guidance also recommended that, where powers had

been delegated, the Committee would receive regular reports on decisions made so that they maintained an overview of the general licensing situation.

For the period 6 February 2010 to 31 March 2010 the Environmental and Technical Services Director had received and determined: 52 applications for Premise Licences; 23 applications for Personal Licences; and 73 notifications of Temporary Event Notices.

RESOLVED:

That the report and the fact that further update reports would be submitted, as necessary, be noted.

7. DETERMINATIONS MADE UNDER THE GAMBLING ACT 2005: PERIOD COVERING 1 APRIL 2010 TO 21 MAY 2010

The Committee considered the report of the Environmental and Technical Services Director, updating on the applications, made under the Gambling Act 2005, which he had determined.

The report indicated that Sefton's Statement of Licensing Policy followed the recommended delegation of functions contained within the "Guidance issued under Section 25 of the Gambling Act 2005"; that in effect, this meant that where there were no relevant representations on an application for the grant of a premises licence or a permit then these matters would be dealt with by Officers in order to speed matters through the system; and that the Guidance also recommended that, where powers had been delegated, the Committee would receive regular reports on decisions made so that they maintained an overview of the general gambling situation.

For the period 6 February 2010 to 31 March 2010, the Environmental and Technical Services Director had received and determined: 6 applications for licensed premises gaming permits; 9 applications for licensed premises automatic gaming; and 1 application for club machine permits.

RESOLVED:

That the report and the fact that further update reports would be submitted, as necessary, be noted.

8. DRAFT REVISED STATEMENT OF LICENSING POLICY - LICENSING ACT 2003

The Committee considered the report of the Environmental and Technical Services Director that sought comments on the draft revised Statement of Licensing Policy. The report also advised Members of the proposals for wider consultation on the draft revised document.

Attached as an annexe to the report was a copy of the draft revised Statement of Licensing Policy.

Officers responded to a variety of questions from Members regarding definitions and points of clarification within the report and added that Sefton Council was doing more than any other local authority in England regarding this matter.

RESOLVED: That

- 1) the draft revised Statement of Licensing Policy, as detailed in the annex to the report, be approved;
- 2) the actions being taken to progress the revision of the Statement of Licensing Policy, subject to the removal of the proposal to undertake 400 interviews with members of the public, be approved; and
- 3) a meeting of the Licensing and Regulatory Urgent Referrals Committee to be arranged discuss the powers available under the Licensing Act 2003 to tackle issues of serious crime.

9. EARLY MORNING ALCOHOL RESTRICTION ORDERS

The Committee considered the report of the Environmental and Technical Services Director on the early morning alcohol restriction orders to be implemented through the proposed changes to be made to the Licensing Act 2003 (LA03) by the Crime and Security Act 2010 (CSA10) indicating that a motion was moved in Parliament on 10 February 2010 requesting the House to "instruct" the Bill Committee to consider certain amendments to the CSA10 to amend the LA03 to give local authorities powers to "ban 24 hour licences in their area"; that whilst the CSA10 received Royal Assent on 8 April 2010, the provisions to amend the LA03 would not come into force until the Secretary of State laid the necessary Commencement Order; and that Section 55 of the CSA10 would amend the LA03 by inserting five new sections (sections 172A to 172E) into Part 9 of the CSA10.

RESOLVED:

That the report and the fact that further reports would be submitted once the provisions came into force be noted.

10. SEX ESTABLISHMENT LICENCE - SEXUAL ENTERTAINMENT VENUE

Further to Minute No. 84 of the meeting held on 22 February 2010, the Committee considered the report of Environmental and Technical Services Director on the sex establishment licence – sexual establishment venue and seeking approval of the adoption of Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982, as amended by Section 27 of the Policing and Crime Act 2009. The report indicated the delegation

of powers to Licensing (Sexual Entertainment Venues) Sub-Committees and the Environmental and Technical Services Director in respect of certain functions under the Policing and Crime Act, 2009 and Schedule 3 of the Local Government (Miscellaneous Provisions) Act, 1982 and the introduction of proposed conditions and fees in respect of this process.

The report also indicated that Schedule 3 of the Policing and Crime Act 2009 (PCA09) inserted a new category of "sex establishment" called a "sexual entertainment venue" into Schedule 3 to the Local Government (Miscellaneous Provisions) Act, 1982 (LGA82), therefore bringing the licensing of lap dancing and pole dancing clubs and other similar venues under the regime set out in the 1982 Act, which was currently used to regulate establishments such as sex shops and sex cinemas, rather than under the Licensing Act 2003 ("the LA03"); that guidance issued by the Home Office indicated that whilst local authorities should judge each case on its own merits, it would be expected that the definition of relevant entertainment would apply to the following forms of entertainment as they commonly understood, namely: lap dancing; pole dancing; table dancing; strip shows; peep shows and live sex shows; that the guidance indicated that the mere fact that there was a display of nudity did not mean that a sex establishment licence would necessarily be required; and that the relevant entertainment must be provided for the financial gain of the 'organiser' or 'entertainer'.

RESOLVED: That

- (1) the adoption of Schedule 3 the Local Government (Miscellaneous Provisions) Act, 1982, as amended by Section 27 of the Policing and Crime Act, 2009; be endorsed;
- (2) the recommended delegation of functions to the Licensing (Sexual Entertainment Venues) Sub-Committee be endorsed;
- (3) the proposed conditions and fees be endorsed; and
- (4) Cabinet be requested to approve the recommendations set out in paragraphs (a) (c) detailed in the report.

11. SEX ESTABLISHMENT (SEX SHOP) LICENCE - SCANDALS ADULT SUPERSTORE, 304 DERBY ROAD, BOOTLE, L20 8LN

The Committee considered the report of the Environmental and Technical Services Director on Sex Establishment (Sex Shop) Licence - Scandals Adult Superstore, 304 Derby Road, Bootle, L20 8LN indicating that a licence was required for any person wishing to operate either a Sex Cinema, a Sex Shop or a Sexual Entertainment Venue under the Local Government (Miscellaneous Provisions) Act 1982; that a Sex Shop is defined as 'any premises, vehicle, vessel or stall used for a business which consists to a significant degree of selling, hiring, exchanging, lending, displaying or demonstrating sex articles or other things intended for use in connection with or for stimulating or encouraging sexual activity

or acts of force or restraint which are associated with sexual activity'; that the Standard Conditions relating to Sex Establishment (Sex Shops) Licences were approved on 22 March 2004 by the Council; that Paragraph 2 of these Conditions stated that: "except with the previous written consent of the Council no sex shop shall be open to the public earlier that 9am in the morning and shall be closed not later than 8pm in the evening on any day Monday to Friday and not later than 9pm in the evening on Saturdays. The sex shop shall not be open on Sundays or any Bank Holidays or any public holidays"; and that the hours requested by the applicants exceeded those allowed for in the Standard Conditions and should Members be minded to grant the application, as applied for, then the Standard Conditions would be amended for these premises only to show the hours as requested.

The application had been advertised in the prescribed manner; no public objections had been received with regard to this application; and a copy of the Standard Conditions was attached as an annex to the report.

Stephen and Lilian Kershaw, applicants, were in attendance at the meeting and spoke in support of the application.

RESOLVED:

That subject to the conditions as detailed in the report and that the renewal of the licence in 12 months time be referred back to the Committee for further consideration, the application for the granting of a sex establishment licence (sex shop) in respect of Scandals Adult Superstore, 304 Derby Road, Bootle, L20 8LN, be granted.

12. THE LICENSING OF LIMOUSINES

Further to Minute No. 104 of the meeting held on 19 April 2010, the Committee considered the report of the Environmental and Technical Services Director on the licensing of limousines, indicating that following the Traffic Commissioner's decision to no longer issue Public Service Vehicle (PSV) Operator licences to cover the hiring of Limousines being used for "drinking parties", vehicles were required to be licensed under the Private Hire legislation administered by local authorities; that Sefton Council conformed to Department of Transport's "Best Practice" for licensing of all limousines and novelty vehicles; that under the Licensing Act 2003 ("the LA03"), alcohol could not be sold on a moving vehicle and the vehicle could not be licensed for that purpose, but licensing authorities could consider applications for the sale of alcohol from a parked or stationary vehicle. The report concluded that a method or framework for hire and reward of licensing and the LA03 licensing were in place and that any complaints received by the Environmental and Technical Services Department would be investigated in consultation with the Police and/or VOSA as appropriate.

LIST OF BACKGROUND PAPERS RELIED UPON IN THE PREPARATION OF THIS REPORT	

Background

- 1. The Cabinet Members will be aware that The Sefton Safer & Stronger Communities Partnership (SSCP) has been assigned the responsibility for the delivery of National Indicator 21 "Dealing with local concerns about ASB and Crime by the Local Council and Police"
- 2. The Comprehensive Area Assessment (CAA) will assess performance and prospects for delivery on the priority indicators. The CAA is a new framework through which the major public service inspectorates will together make independent assessments of how well people are being served by their local public services. Its focus is primarily on the prospects for better outcomes locally rather than the internal workings of individual organizations.
- 3. A key factor in satisfying NI21 is having baseline data which can inform intelligence led interventions and serve as a benchmark for assessing progress.

Best Bar None

- 4. Best Bar None is a national award scheme which recognises and rewards well managed licensed premises. It is centred round the four licensing objectives; prevention of crime and disorder, prevention of public nuisance, public safety and the protection of children from harm.
- 5. The scheme was developed by the Manchester City Centre Safe as part of its remit to address alcohol related crime. The aim was to enhance and complement traditional law enforcement activity by consensual approach to help to deliver a safer night time economy. Good operators were rewarded through Best Bar None; bad operators were similarly identified and tackled through targeted enforcement activity. Best Bar None has since been adopted by many towns and cities across the UK and is even now being taken up in parts of Europe, USA, New Zealand and Australia.
- 6. The objectives of Best Bar None are:
 - To reduce the risk of alcohol related harm, disorder and crime.
 - To establish a benchmark of good practice in licensed premises.
 - To identify and reward responsible operators and share their good practice with others.
 - To create consistency of standards throughout the UK with which to underpin the alcohol harm reduction strategy and the 2003 Licensing Act.
 - To improve the knowledge and skills of enforcement and regulation agencies, licensees and bar staff in order to deal effectively with issues relating to the management of licensed premises and to understand how this can reduce alcohol related crime and disorder, minimise the harmful effects of binge drinking, whilst improving profitability of an individual business and attractiveness of a general area.

- To raise public awareness of choosing to use well run licensed premises, thereby increasing public reassurance and the promotion of social inclusion and diversity of use.
- To create a positive vehicle for all sectors of the night time economy to work together in partnership for the common good.
- To improve the attractiveness and economic vitality of the awards area.
- 7. Best Bar None was initially introduced in Sefton through the Safer Stronger Communities Partnership (SSCP) by Merseyside Police in 2007 when Southport town centre pubs, clubs and bars were invited to apply. In 2008, the scheme was broadened to include all districts within the Borough, and 'The Willow Grove' in Southport was the overall winner. In early 2009, the SSCP invited the Council's Trading Standards Service to take over the management of the project
- 8. The 2009/10 Best Bar None competition was launched in Sefton in May 2009 and 13 applications were returned before the deadline on the 30th September. There were 3 applicants from Southport, 2 from Formby, 2 from Waterloo / Crosby and 1 from each of Hightown, Sefton Village, Maghull, Aintree, Bootle, and Thornton.
- 9. The application form served to guide the licensed premise through all the issues that should be considered in compiling and delivering an effective operating schedule and included:
 - Security, security reviews
 - Managing capacity
 - Dealing with drunkenness
 - Dealing with drugs
 - Thefts and burglary
 - Disorder
 - First Aid
 - Event control
 - Glass collection and glass safety
 - Building safety and fire control
 - Noise control
 - Community engagement
 - Litter
 - Underage sales
- 10. The Premises were judged on the number of policies and procedures they had in place to ensure they met all the essential criteria applicable to their premise to be accredited under the scheme. The essential criteria are:
 - Carrying out regular security reviews
 - A policy on searching patrons
 - Management and staff ensure drunkenness is managed on the premises
 - All staff receive training in relation to handling drunkenness
 - Policies in place to prevent the use and supply of drugs on the premise
 - Procedures in place if illegal drugs are discovered on the premises, including how to surrender any drugs to the police

- Toilet attendants/documented toilet checks are carried out
- A clear anti-theft strategy is in place
- A lost property recording system is in place
- Strategies in place for dealing with disorder/conflict
- A policy in place to prevent overcrowding
- A written accident recording system in place
- Procedures are in place for building evacuations in the event of an emergency (fire, terrorism, power loss)
- An effective glass collection policy is in place
- An effective spillage and broken glass policy is in place
- The police and any relevant agencies are notified of any special events that are not already included on the licence, which may impact on the neighbourhood to a much greater extent than normal trading practice
- A written fire safety risk assessment in place, which has been completed and reviewed in the last 12 months
- Staff receive documented training in fire safety procedures
- Daily pre opening checks are carried out
- Fire fighting and safety equipment is inspected/serviced annually
- Processes, procedures and policies are in place to ensure noise disturbance from the operation of the premises and from customers is kept to a minimum
- A dispersal policy is in place
- Documented procedures are in place to minimise the risk of under 18s buying, consuming or being supplied with alcohol
- A proof of age policy is in place
- There is documentary evidence of staff training in relation to age/alcohol related offences
- There are posters and other materials displaying warnings about underage drinking and stating that proof of age may be required
- 11. Applicants received additional bonus points for extra initiatives they have in place such as, providing a free taxi phone service, involvement in community initiatives, promotion of soft drinks to drivers.
- 12. Independent assessors verified the claims made by the premise during a comprehensive assessment visit. 11 premises, (2 withdrew at the assessment stage) underwent consistent, vigorous assessments by 2 independent assessors and all of them were accredited. This meant that they met all the essential criteria necessary to become a Best Bar None premise and display a commemorative plaque and use the BBN logo. This was twice the number of accredited premises compared to 2008.
- 13. The accredited premises were then put forward to the marking stage were they were marked and ranked according to their score comparing like for like. As all the applications were of a high standard, they were all put forward to the judging phase where a panel of judges examined the applications together with a comprehensive breakdown of the scores for each category.
- 14. The 2009/10 winners were announced at the Awards Ceremony on 26th January 2010 at the Jospice Academy. All 11 premises received accreditation certificates and plaques to be displayed on their premises. In addition 5 premises were Highly Commended and they received a further plaque. The overall winner received a Winners Plaque and trophy together with free advertising on 3 hackney cabs which will also serve as advertising for next year's scheme. In addition the winner has been invited to a Parliamentary reception. All premises have also been listed on the tip seats of 10 further hackney cabs within the borough.

The Way Forward

- 16. The 2010/11 Best Bar None competition was launched at the beginning June when all the pubs, clubs and bars across Sefton were invited to apply. Offers of help in completing the forms and meeting the minimum requirements will again be advertised and new members will be encouraged to apply through personal visits and Pubwatch meetings. The closing date for applications is the 30th September 2010. Assessment visits will take place during October and November. The judging will take place in December and the Awards Ceremony will be held in January, 2011.
- 17. Best Bar None is a well recognised scheme, supported by the government and the licensed retail industry, which is being successfully run in a number of local authorities. Such schemes serve to promote the local economy whilst tackling anti social behaviour, and act as a catalyst for joined-up thinking on a wide range of policies in the management of the night time economy.

- 1. Members will recall that, on 23rd November 2009, the Licensing and Regulatory Committee considered a report entitled "An Update on the Provision of the Taxi Licensing Facilities by Sefton Plus".
- 2. That report highlighted Service performance for the period 1st April 2009 to 30th September 2009 and can be summarised as follows:
 - 1108 of the available 1181 appointments available were booked at the Bootle One Stop Shop. **35%**, **(383)** were not kept by the trade.
 - 560 of the available 946 appointments available were booked at the Southport One Stop Shop. **18%**, **(100)** were not kept by the trade.
 - 483 failed appointments equates to 241.5 officer hours wasted, ie 33.5 days.
 - A total of 512 appointments remained unbooked, 392 in Southport One Stop Shop.
 - There were 6996 "drop ins" in the Bootle One Stop Shop of which 3% (233) did not wait to be seen.
 - There were 1296 "drop ins" in the Southport One Stop Shop of which 1% (18) did not wait to be seen.
 - 1470 Knowledge Test places have been offered at the Bootle One Stop Shop, 89% of which were booked. 30% of candidates failed to attend their appointments. 345 (43%) of the 920 candidates who attended passed the test.
 - 1060 Knowledge test places have been offered at the Southport One Stop Shop, 75% of which were booked. 25% of candidates failed to attend their appointments. 254 (43%) of the 589 candidates who attended passed the test.
 - The average pass rate was 40%
 - The number of licence applications received over the period is up by 13.93% compared with the same period in 2008/09.
- 3. The report also concluded that there was available capacity in the Appointment system in both One Stop Shops, which if used could reduce the number of "drop ins" and waiting time, not just for the Trade but other Council clients.

Purpose of Report

To advise the Licensing & Regulatory Committee of requests from eight VOSA approved MOT stations to be appointed as Sefton Hackney Carriage & Private Hire Compliance Testing Stations

Recommendation(s)

That the Committee:

- 1. Determine the eight outstanding applications and appoint the eight additional garages as approved Hackney Carriage & Private Hire Compliance Testing Stations.
- 2. Limit the maximum number of approved Hackney Carriage & Private Hire Compliance Testing Stations to twelve pending and without prejudice to the outcome of the review of the Council's Hackney Carriage & Private Hire Compliance Testing policy.
- 3. Instruct the Taxi Licensing Team Leader to advise all the Sefton appointed Hackney Carriage & Private Hire Compliance Testing Stations that their status is subject to review and that no facility is guaranteed to remain authorised as a Compliance Test Facility if it does not meet the minimum standards subsequently determined by the Council.

Background

- 1. The Licensing & Regulatory Committee will recall the report "Hackney Carriage & Private Hire Vehicles Compliance Testing Approval of Additional Facility" presented on 18th January 2010. That report advised the Members that:
 - a) The Council is currently authorised by the DfT Vehicle Inspectorate Agency to test vehicles under a compliance testing scheme in accordance with the Motor Vehicles (Test) Regulations 1981 (as amended) The current certification was renewed in 8th July 1998.
 - b) The authorisation terms require that only Vehicle and Operator Services Agency (VOSA) approved facilities based within the political boundary of the Council may be used.
 - c) The use of this compliance scheme means that, in addition to the standard "MOT" test, the council can specify additional items, which it considers necessary to safeguard the best interests of the travelling public of Sefton.
 - d) In 1998 there were a total of 1673 vehicles licensed, all of which required compliance testing via three facilities. In 2002 the Council facility of Pine Grove was approved but that subsequently ceased to be VOSA approved on the move to Hawthorne Road in 2006.
 - e) There are currently approximately 2910 licensed hackney carriage and private hire vehicles, which are licensed by Sefton, an increase of 74% over the earlier 1998 figure of 1673 vehicles.
 - f) That the trade had reported delays of up to four days in putting vehicles through a test resulting in commercial disadvantage and
 - g) There have been longstanding requests from Trade Stakeholders requesting an additional facility in the north of the Borough.
- 2. On 18th January 2010, the Committee resolved, (Minute 71) that the request from the Joint Trades Consultation Group for the appointment of an additional Hackney Carriage and Private Hire Compliance Testing Station (Berry Street Garage, Bootle) be approved and also requested the Environmental and Technical Services Director to carry out a review of the Council's testing scheme and facilities.
- 3. A number of additional VOSA approved MOT stations have recently submitted applications, requesting to be added to the Council's list of appointed Hackney Carriage & Private Hire Compliance Testing Stations. These applications require determination.

Current Position

- 4. The appointment of the Council's Hackney Carriage & Private Hire Testing Stations has historically been reserved to the Licensing & Regulatory Committee.
- 5. Sefton Council currently does not have any independent policies relating to the quality of testing facilities to assist the determination of new vehicle testing

stations. This has been recognised and the review of policy in this area has been initiated.

- 6. The Vehicle and Operator Services Agency (VOSA) does however operate an internal verification assessment scheme for all authorised MOT Testing facilities in England and Wales. This scheme assesses the quality of authorised facilities as Green, Amber or Red. All three classifications permit continued testing of vehicles on behalf of VOSA. If a facility is considered no longer fit to test then a short- term cessation notice is issued or the authorisation is revoked.
- 7. The "Traffic Light" system is based on several different factors. Not all matters relate to the testing of vehicles. The Disciplinary record held at VOSA of each facility is combined with the resultant score of the site assessment and determines that facility's current status. Red or amber means that there will be a further inspection within the next 18 months. Green means that the next inspection will usually be in three years time, unless other complaints are received in the interim.

8. Relevant factors include:

9. Facilities with a poor score cannot request a further assessment as soon as they have remedied defects. They must wait until the next date selected by VOSA. Therefore a facility graded "red" may remedy all the causes of that grading within a week yet remain graded "red" until 18 months later when next assessed. Existing facilities which change hands and which retain at least one Tester from the old regime retain their score and assessment. All new facilities and those where the old testers leave are assessed within six months of appointment.

10. There are currently four appointed Hackney Carriage & Private Hire Compliance Testing Stations within Sefton.

Each Hackney Carriage & Private Hire Compliance Testing Station has been inspected by the councils enforcement staff for testing standards, paperwork, key security etc and have taken regard of the VOSA 'traffic light' assessment of each facility.

Applications or Additional Testing Facilities

11. The following VOSA approved MOT stations have recently applied to be added to the list of appointed Hackney Carriage & Private Hire Compliance Testing Stations:

- 12. At the Trade Stakeholder Meeting, 23rd March 2010, the group discussed the current facilities for the testing of hackney carriage and private hire vehicles. A clear consensus of support was expressed for additional appointments and the following points were made:
 - a) There were significant differences between the testing of Hackney carriages and Private Hire Vehicles as opposed to ordinary cars;
 - b) That all Sefton Council appointed Compliance Testers and Licensing Officers should undertake specialised compliance test training;

- c) It was stressed that the maintenance of standards was of great importance and the VOSA Traffic Light system, i.e. facilities being given Green; Amber or Red status was an aid to this aim.
- d) That the other main issue was the need for the availability of a test within a reasonable period of time; and
- e) That any future review should consider points (a-d) above as important in any Review.
- 13. The current number of Sefton licensed vehicles, as of the 27th May 2010, was 2966. Of those some 336 require twice yearly testing. Therefore, if 100% of vehicles passed first inspection, a minimum of some 3300 tests per annum would be required, split between the existing and applicant facilities giving an average of 275 tests per annum per facility. The overall failure rate at first presentation currently averages 45% across the borough. Appointment of the additional Hackney Carriage & Private Hire Compliance Testing Stations should satisfy demand and provide a comprehensive network of testing stations across the Borough.

The Review


- 14. Further to Minute 71 of the Licensing & Regulatory Committee Meeting 18th January 2010, the Environmental Protection & Technical Services Director has commissioned a review of the current polices & procedures relating to Testing Stations. The Review will commence in July 2010 with a view to reporting its conclusions and making its recommendations to the Licensing & Regulatory Committee in November 2010.
- 15. The Review will be carried out by the Taxi Licensing Team leader and will consider:
 - a) Existing Policy & procedures
 - b) Custom & Practice
 - c) Testing Stations Standards
 - d) Codes of Good Practice
 - e) Benchmark with other Local Authorities
 - f) Feedback from the Trade and
 - g) The Views / Concerns of the Testing Stations.
- 16. That review may result in changes to the existing scheme and all the garages detailed in paragraphs (10) and (11) will be advised that there is no guarantee that they will be retained as a compliance testing station beyond that review if they do not meet the revised minimum standards within a notified timescale. Member's comments are welcomed at this stage prior to the start of the Review.

17. It is recommended that the review consider a cap on the total number of approved testing stations to allow effective quality control inspection by enforcement officers.

ISSUES FOR CONSIDERATION

- 18. The appointment of the Council's testing facilities has historically been reserved to the Licensing & Regulatory Committee and the Committee is requested to determine the eight outstanding applications.
- 19. In view and without prejudice to the outcome of the review, members may wish to consider temporarily limiting the maximum number of potentially approved testing stations to twelve.


