1.0 Introduction

2.2

- 1.1 A report was submitted to the Cabinet Member Technical Services at his meeting of the 8th October 2008 which outlined the whole of the Cycle Town Project to be delivered over three years between April 2008 and March 2011.
- 1.2 The report further indicated that the grant of £1.8m of revenue and capital funding from the Department for Transport through the delivery agency Cycling England was subject to an annual work programme being agreed with Cycling England. The funding was to be split £300k in 2008/9, £750k in 2009/10 and £750k in 2010/11.

The work programme for 2010/11 has been submitted to Cycling England and has now been approved. This report seeks the inclusion of the Work programme in the Capital programme for 2010/11.

2.0 Details of the Work Programme 2009/10

2.1 The work programme for 2010/11 is detailed in 2.2 below. This has been over programmed by £150k with a scheme to upgrade the Transpennine Trail between Selworthy Road and Weld Road, which will be developed to feasibility stage initially, in case of problems delivering other elements of the programme. The total expenditure on the programme for 2010/11 will not exceed the £560,000 allocation.
