1. Introduction/Background

- 1.1.1 At its meeting held on 24 May 2012, the Cabinet considered a report of the Director of Corporate Commissioning seeking the appointment of representatives on Outside Bodies. The Cabinet approved the appointment of various representatives, including that of Councillor Hardy to serve on the North Western Inshore Fisheries and Conservation Authority
- 1.2 In accordance with the Marine and Coastal Access Act 2009, the North Western Inshore Fisheries and Conservation Authority is tasked with the sustainable management of inshore sea fisheries resources in the area from the Wirral Peninsula to the Duddon Estuary. It is made up of representatives from the constituent local authorities (who provide funding for the Authority through levies raised) along with people from across the different sectors that use or are knowledgeable about the inshore marine area, such as commercial and recreational fishermen, environmental groups and marine researchers, who offer their time voluntarily.

Meetings are held quarterly in March, June, September and December.

- 1.3 It is recommended that Councillor John Joseph Kelly be appointed as the Council's representative on the Consultative Committee for the remainder of the current Municipal Year in place of the Cabinet Member Communities and Environment (Councillor Hardy).
- 1.4 Both Councillors Hardy and John Joseph Kelly have been consulted on this matter and are happy with the proposed change.
